PLAN COMMISSION BUSINESS

- David Funk/Paul Broege moved to open the Public Hearing for Mother-n-Law Suites.

 separate utilities. Concern on how to enforce. Great idea to put in place before you need
 it. Could require that it needs a CUP (Conditional Use Permit).

- David Funk/Paul Broege moved to recommend Mother -n-Law Suites being allowed in all zoning with a recorded CUP. Motion carries
- Application from Loren and Jan Bobolz to divide the parcel 6-10-155 which is on Belding Rd. for a family member to build a home. The parcel is 57 acres and they would like to set off 3.83 acres. Stated they are willing to deed restrict the remaining 54 acres. Rob Atkinson/David Funk moved to hold a Public Hearing on this request. Motion carries.

- Application for a Land Division Rezone & Variance for the Tim Howard Estate represented by Tammy Mueller. This is for parcel 6-10-165 at 4420 S Milton Shopiere Rd. Janesville. It is an 80-acre parcel. They would like to setoff 10 acres with the homestead and pasture land. The variance is for an additional 2 acres to remain with the home parcel.
- Plan Commission: David Funk/Peter Daluge moved to hold a Public Hearing on the matter.
- Board of Appeals: David DeLong/Mark Schroeder moved to schedule a Public Hearing.
 Both motions passed.

- Application for a Land Division Rezone & Variance for the Helen Sagen Estate represented by David Sagen. It is parcel 6-10-146A at 3741 Maple Lane Janesville. They are still working on how many acres will be setoff to have completed by August 30th. A variance is required due to the parcel being under 50 acres.

- Board of Appeals: David DeLong/Erin Conway moved to schedule a Public Hearing. Both motions passed.
